I want to thank all staff and residents for your willingness to participate in the testing processes and especially thank all the nursing staff who worked tirelessly to perform all testing within 48 hours. We are truly blessed to have such dedicated staff!

Shelter in Place Order for Long Term Care Facilities Guidance

I understand that many of you have been receiving lots of questions regarding the Shelter in Place order for LTCFs. Several partners have been asking if the Shelter in Place order expires at the same time as the Public Health Emergency, which ends on 10/10/2020, or if the Shelter in Place order ends on 9/15/2020 per the Empowering Healthy Georgia Executive Order.

Per State leadership, the Shelter in Place requirements is only part of the guidance included in the Executive Order (“Providing additional guidance for Empowering a Healthy Georgia in Response to COVID-19”)– the most recent one being 08.31.20.02, which expires 09/15/2020 at 11:59pm.

However the Executive Order did extend additional orders for long-term care facilities states below:

*****Long-term care facilities should continue to restrict visitors and non-essential personnel through October 10, 2020 per Executive Order 04.08.20.03. *****

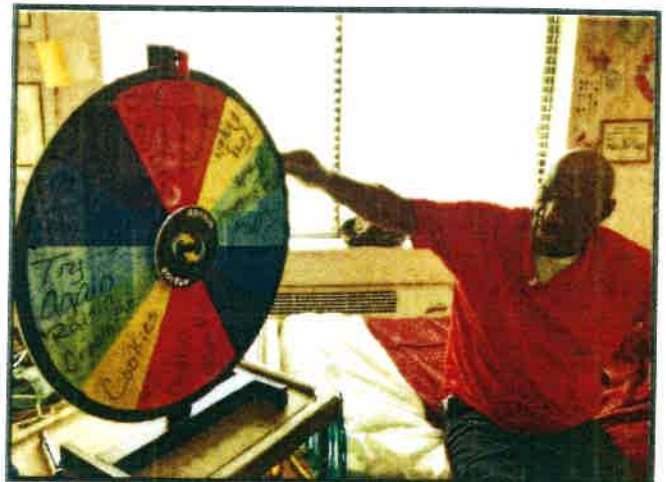

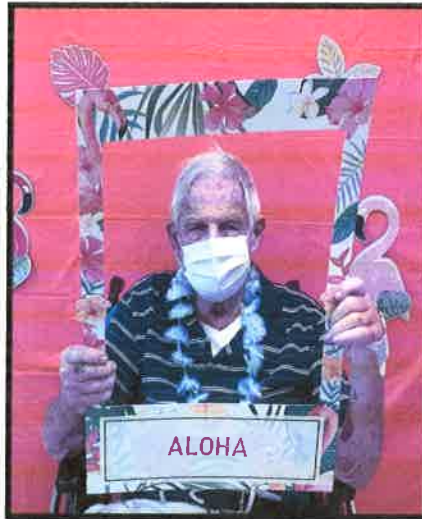

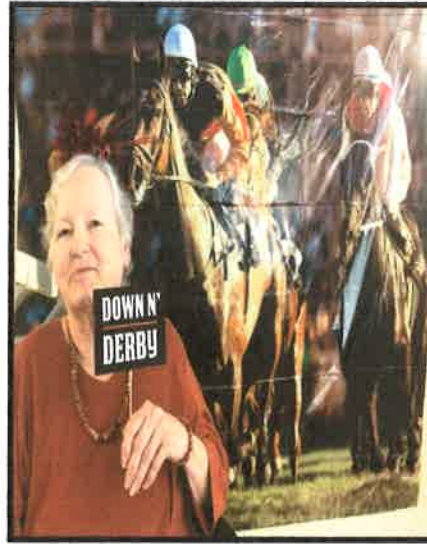
